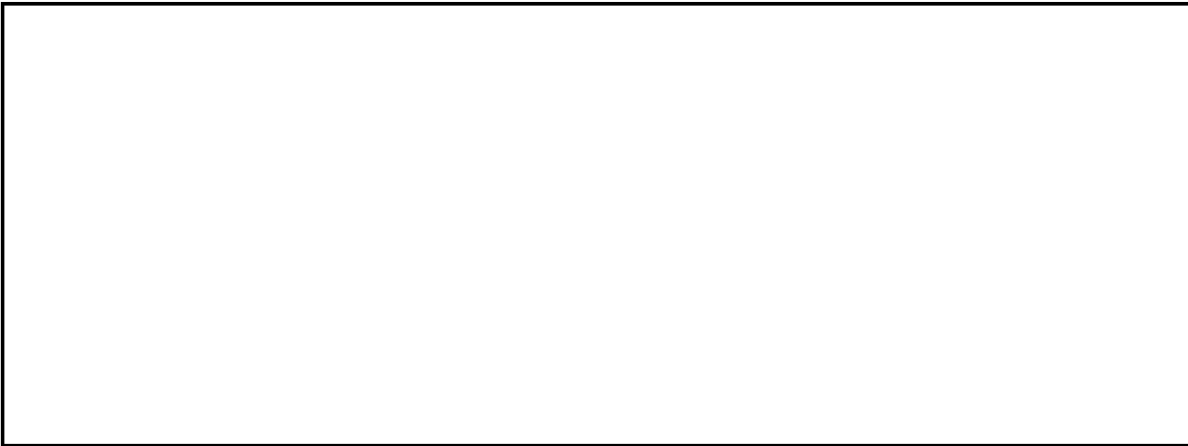

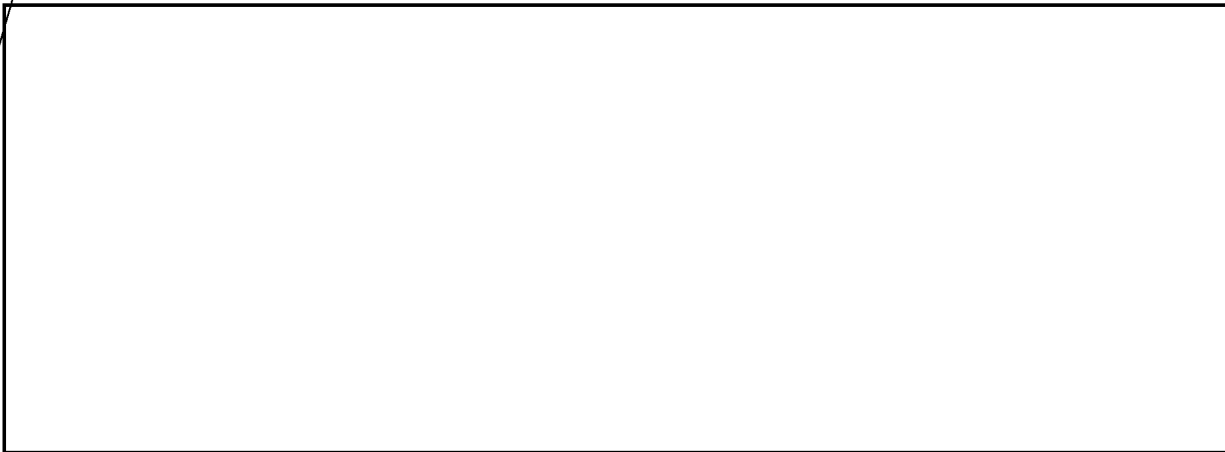

before 9:00am on 09/11/2001. She received a telephone call from  
[redacted] a friend who lives in apartment [redacted] in the building.  
[redacted] told [redacted] that there was smoke coming from the World  
Trade Center (WTC). [redacted] looked out her window and saw  
smoke coming from the towers. [redacted] ended the call and [redacted]  
took a pair of binoculars and walked over to the window. When she  
looked out, she also noticed a white van parked in the parking lot  
for her building, approximately five or six parking spaces from the  
south end of the lot, in a direct line between her and the WTC.  
There were young three men on top of the van, which was parked at  
an angle pointing directly at the WTC. She saw one of the males  
holding a small video camera. One of the men had his hand on the  
shoulder of the other and they appeared to be happy and "joking  
around."

[redacted] said she could not see the rear license plate  
of the van because a sun deck attached to the building blocked her  
view. However, when the van departed several minutes later, the  
vehicle backed out, backed down the driveway from [redacted]  
right to left, and then backed into a space in front of [redacted]  
while making a K-turn, giving [redacted] an unobstructed view of  
the rear of the vehicle.

Approximately two hours after the above interview,  
[redacted] was contacted by telephone and asked for further  
information about the video camera she believed was utilized by one  
of the men. [redacted] described it as a small, dark colored  
video camera and said she observed a "pop-out" screen on the side  
of the unit that displayed the image seen through the lens. She  
noted that the male using the camera held it up continuously for  
several minutes and moved it around, as if he were panning the  
view.

After being advised of the identity of the interviewing agent and the nature of the interview, she provided the following information:

[redacted] works for Oxford Health Plans, an insurance company located in Nashua, New Hampshire. Oxford provides health insurance to individuals and groups, with their group insurance providing most of their business.

[redacted] noticed that a vehicle belonging to Urban Moving Systems had appeared in media coverage surrounding the World Trade Center event on 09/11/2001. [redacted] recalled that Urban Moving Systems held insurance through Oxford, and verified that Urban Moving Systems continued to carry insurance through Oxford. After consulting Oxford's legal department, [redacted] contacted the FBI in case information Oxford possessed regarding Urban Moving Systems would be of value to the FBI.

[redacted] provided information regarding Urban Moving Systems, as well as a second company, Shleppers Moving and Delivery Service, Inc (aka Flat Rate Moving Systems, Inc), that insured [redacted] and [redacted] (later employees of Urban Moving Systems). This original copy of this information is included in the FD-340 accompanying the original FD-302; copies of this information are attached to the remaining copies of this FD-302.

During his youth, he traveled with his family to Hungary, Poland, and Czechoslovakia.

He was curious to learned what the commotion was about but continued to the bus platform because he knew he was behind his normal schedule and did not want to delay his trip any further. On one occasion [redacted] was able to walk close enough to a television to notice that what had captured everyone's attention was what appeared to him to be buildings on fire. He was able to confirm this fact when he heard commuters on line to broad bus 126, and later during the bus ride to work, discussing a fire at the "Twin Towers."

The families of the five, who asked that their names not be  
released, said that their sons had been questioned by the FBI for  
hours on end, had been kept in solitary confinement for three days,  
and had been humiliated, stripped of their clothes and blindfolded.

The mother of one of the young men explained the chain of  
events as she understands it to Ha'aretz. She said that the five  
had worked for the company, which is owned by an Israeli, for  
between two months and two years. They had been arrested some  
four hours after the attack on the Twin Towers while filming the  
smoking skyline from the roof of their company's building, she  
said. It appears that they were spotted by one of the neighbors  
who called the police and the FBI.

The mother said that the families and friends of the five in  
Israel had known nothing of the men's whereabouts for a number of  
days. "When they finally let my son make a phone call for the  
first time to a friend in the United States two days ago, he told  
him that he had been tortured by the FBI in a basement," the mother  
said. "He was stripped to his underwear; he was blindfolded and  
questioned for 16 hours. They thought that because he has  
citizenship of a European country as well as of Israel that he was  
working for the Mosad."

Seven FBI agents later stormed the apartment of one of the  
Israelis, searched it and questioned his roommate. The Israeli  
owner of the company, who has US citizenship, was also questioned.  
Both men were subsequently released.

The families here complained that the Israeli Consulate in New  
York and the situation room set up by the Foreign Ministry to  
locate missing Israelis had done nothing to help their sons. The

The five were transferred out of the FBI's facility on Saturday

Aviv Ma'ariv in Hebrew on 17 September adds: "The day of the attack the five Israelis, all of them employed by a local moving company, went up to the roof of a Manhattan building and started to videotape the scene around them, all the while telling 'macabre' jokes, playing back the shots of the collapsing towers, and 'having fun.'

["Their boisterous behavior aroused the attention of policemen, who proceeded to arrest the five. FBI agents were called in to take part in their investigation, as the policemen thought the youths had been rejoicing over the terrorist attack.

["The authorities eventually accepted their explanations that they had merely exhibited a type of 'black humor.' Following the Israeli Consulate's intervention, the US authorities agreed not to bring the youths to trial, who will apparently be deported to Israel in the coming days."]
